Introduction

In the Name of Allah, the Most Gracious, the Most Merciful The Manual of European & Arab Islamic Organizations Advocating for Civil & Political Rights in Northern & Southern Europe was fulfilled under the supervision of Hiwar Center for Studies in the Gaza Strip, and funded by PALM Strategic Initiatives Centre from March to October 2022.

The project is a qualitative effort, as it is perhaps the first of its kind in Palestine to search in Northern & Southern European societies for all civil rights advocates, human rights activists and injustice opponents. It also provides a brief and easy guidance so that all advocates for Palestinian rights, both official and unofficial, inside and outside Palestine, can communicate with these organizations in the targeted areas in favor of the Palestinian cause.

The manual basically aims to introduce lists and keys of the most prominent European & Arab Islamic Organizations advocates for civil and political rights in Northern & Southern Europe. In addition, it comes with a brief definition that highlights the importance of the organization and provides general information without detriment to their essence. Moreover, the manual includes these entries websites addresses to facilitate communication and influence on them.



Introduction

The wide spectrum of organizations advocating for civil and political rights in Northern & Southern Europe has set general framework and specific criteria for the research team.

These criteria are confined to organizations that are active in the European scene, have a vast audience and a real influence on them. In other words, the manual does not include all organizations in Northern & Southern Europe but a specific group with which constructive communication and interaction can be made to serve the Palestinian cause.

Alhewar Centre for studies (HIWAR)

A Palestinian non-profit organization licensed by the Ministry of Information that was founded in 2001 in response to the urgent need for research and intellectual conclusions to guide Palestinian decision-making, improve awareness, and deepen the political thought of the Palestinian public.

The centre aims to correct a political decision, disseminate political culture and develop the political capacities of those interested and willing by keeping abreast of developments on the national, regional, and international arenas, studying their political dimensions, and determining the best response to them by producing books, studies, political papers, opinion polls, holding specialized dialogues, organizing research events and training programmes.



PALM Strategic Initiatives Centre

The Center for Strategic Initiative Palestine-Malaysia was established on July 16, 2019, in Gaza City. Its purpose is to tell Southeast Asian countries about Palestine and its issue, and to invest their energies to stand by Palestinian people.

The centres platforms are bilingual languages: English and Malay, and are staffed by a specialized staff, with certificates in history, political science, media, and translation.



Vision:

The first source for Malayo-speaking countries in receiving information on Palestine and its issue.

The message:

A Palestinian-Malaysian center that uses research, media, publishing, and translation to convey awareness about Palestine and its issue to Malay speakers in the hopes of reducing hatred.

The aims:

1. Accurately disseminating information on Palestine and its issue.
2. Exposing the Israeli violations against the Palestinian people.
3. Mobilizing public opinion behind the Palestinian issue.
4. Influencing decision-makers to take positions that support the Palestinian issue.

Acid Survivors Trust International (ASTI)

A charity, based in London, is considered an international organization that focuses on ending acid violence. ASTI was founded in 2002 in cooperation with six local partners in Uganda, Pakistan, Bangladesh, and Cambodia. It provides medical assistance and conducts various research to support acid attack survivors.

Amnesty International

A global movement, founded in 1961, and based in London, is one of the largest grassroots human rights organizations in the world. Amnesty International defends freedom of expression, fights against torture, and seeks to release political prisoners around the world and support their families. In addition, it has offices in more than (50) countries, and about 3 million members in more than (150) countries. It is worth mentioning that in 1977, it received the Nobel Peace Prize.
